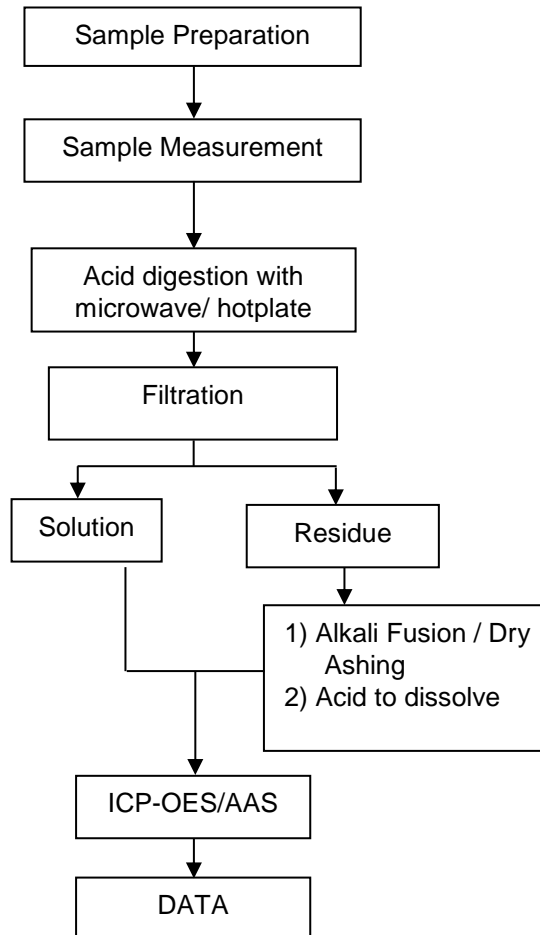

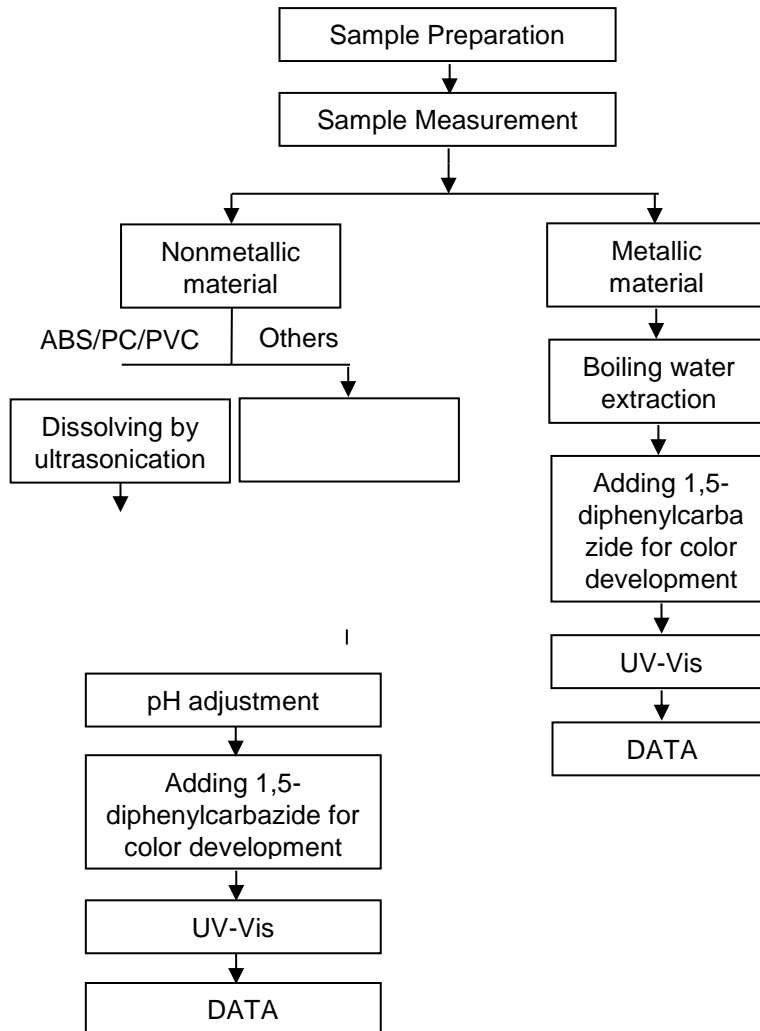

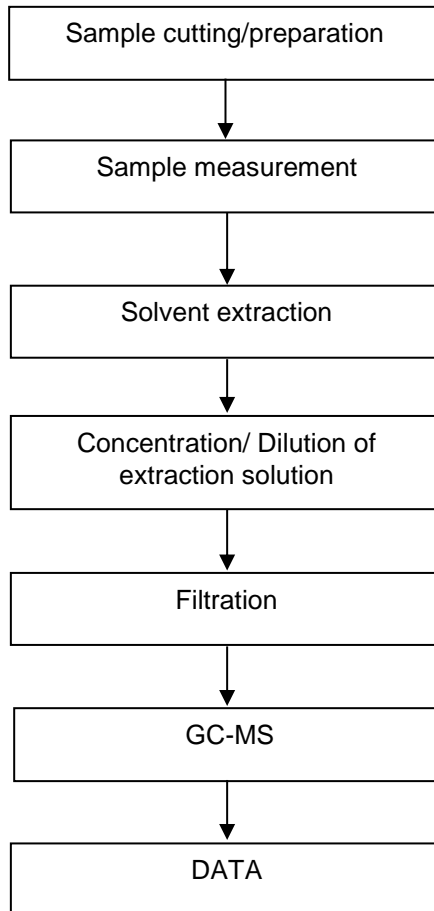

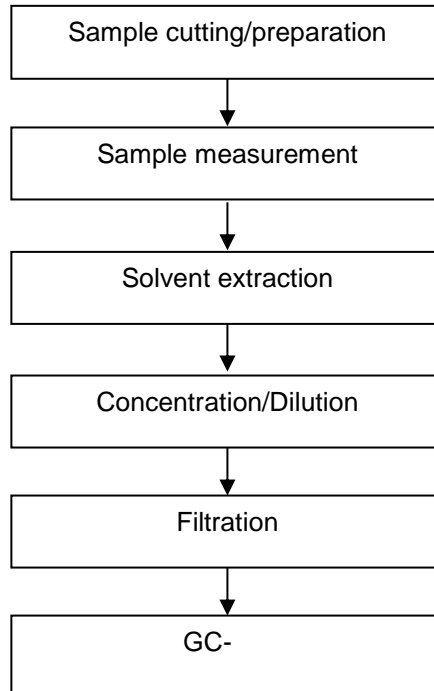

**Halogen Testing Flow Chart**

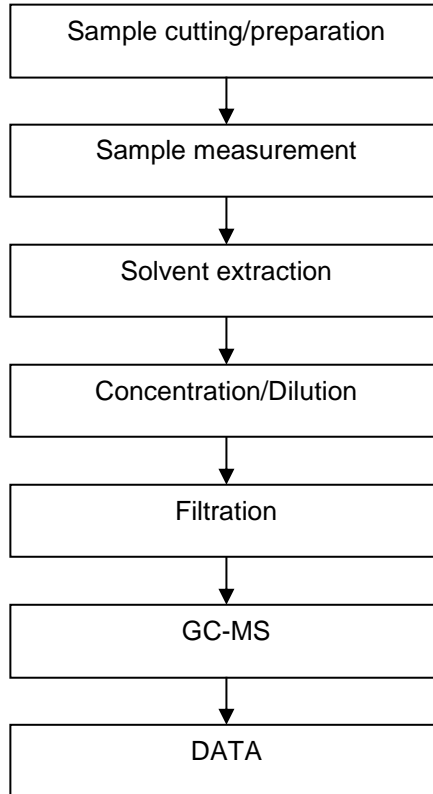
