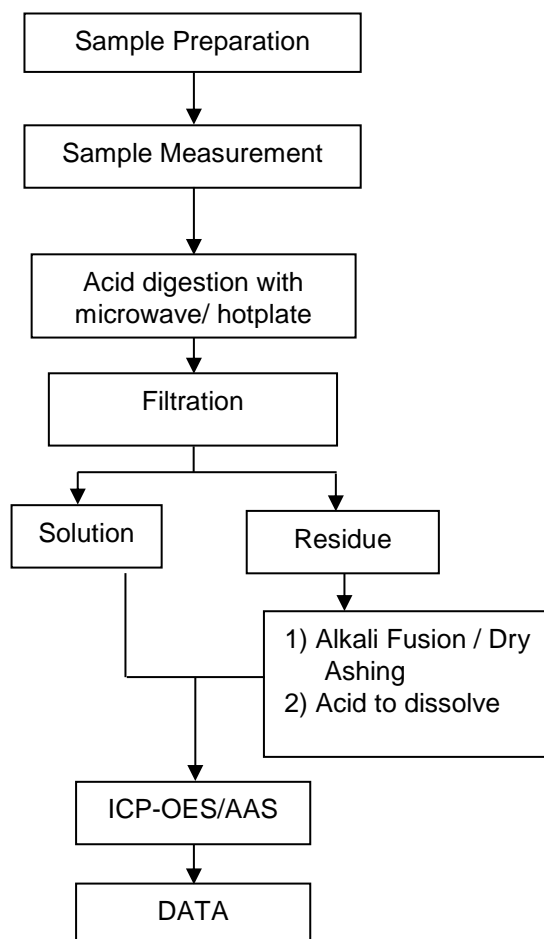

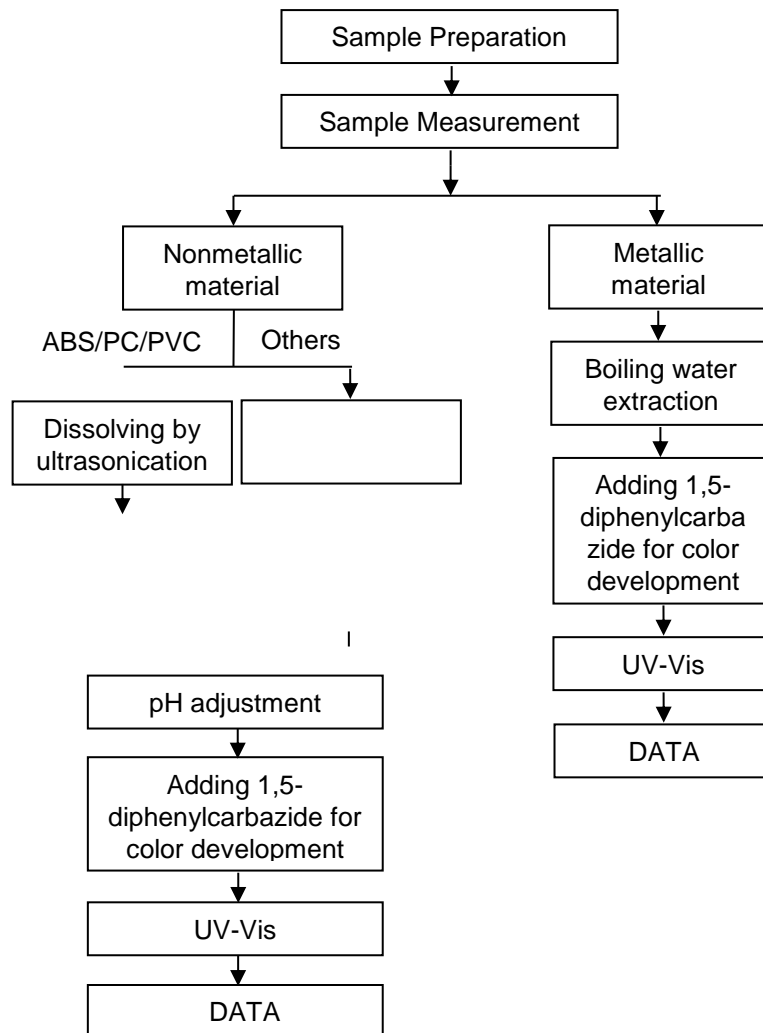

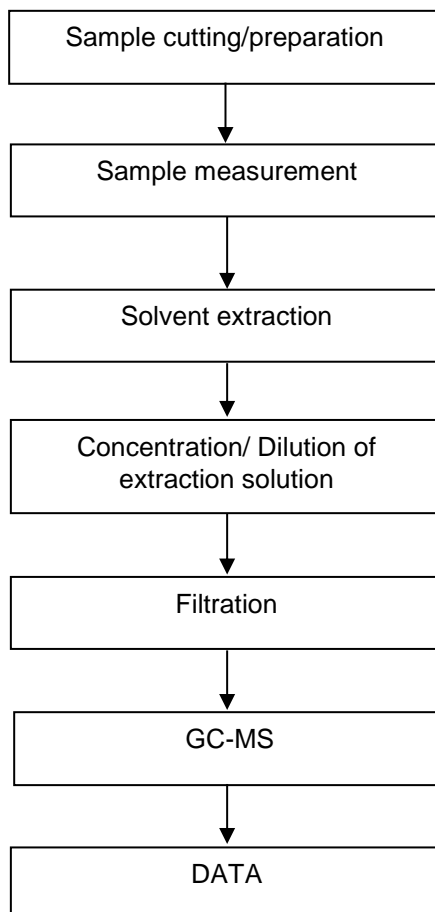

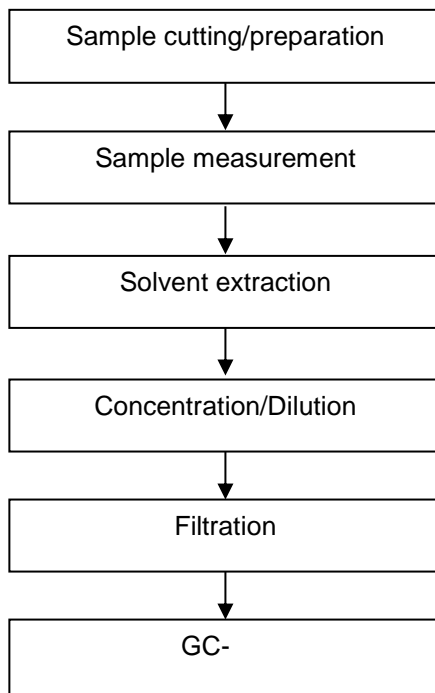

Halogen Testing Flow Chart

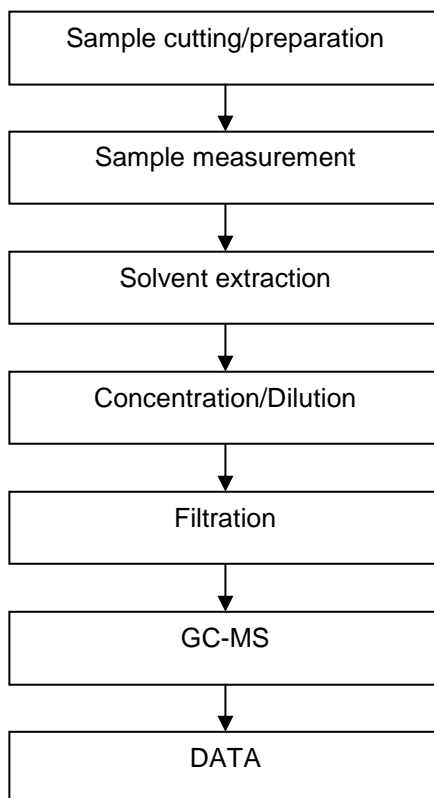

HBCDD Testing Flow Chart

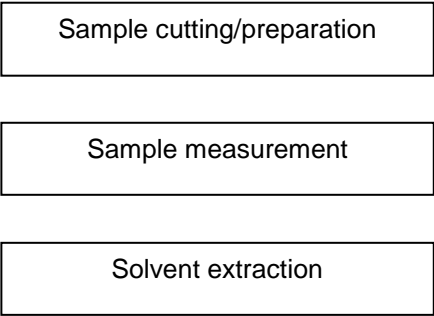
